

# INTERNATIONAL AUCTION SKSCO/ BA \ ٤٠٠٠

South Kaveh Steel Company (SKSCO) intends to sell BILLET ٢٠,٠٠٠ MT GRADE ٢SP of its steel billet products, based on the attached technical specifications, through an international auction (Reference No. BA \ ٤٠٠٠). All companies active in the field of steel export are hereby invited to submit their official purchase requests and proposals. Submissions must be organized into three separate envelopes (A, B, and C), all enclosed within a single sealed master envelope.

**Submission Deadline:** No later than ١٤:٠٠ (Tehran Time) on Monday, August ٢٤, ٢٠٢٦ (٢ Shahrivar ١٤٠٥).

- A. **PRIME STEEL BILLET:** ٢٠,٠٠٠ MT GRADE ٢SP
- B. Any special grade or chemical composition requested by the Buyer shall be subject to an additional charge. For each ٠,١٠ % increase in manganese (Mn) content above the base specification, an additional charge of USD ٢,٠٠ per MR shall apply. Such additional charges shall be for the Buyer's account.
- C. **TERMS OF AUCTION:**  
**Delivery:** FOB Bandar Abbas Port, Iran.  
**Insurance:** The buyer is responsible for insuring the cargo.  
**Vessel Nomination:** The Buyer shall nominate a vessel within fourteen (١٤) calendar days after receiving SKSCO's notice of cargo readiness at the loading port. Any storage, warehouse, and related charges incurred due to late vessel nomination shall be for the Buyer's account.
- D. **TERMS OF PAYMENT:**  
**C-١-** ٣٠% cash as advanced payment and guarantee to fulfill the commitments in max. ٥ working days after SKSCO's order confirmation. If the commitments are not fulfilled by the buyer on time at any stage, the seller is authorized to collect all fines and losses from ٣٠ % and unilaterally terminate the order.  
**C-٢** Remaining ٧٠% of the total Contract value shall be completed prior to the commencement of loading. In the event that payment has not been received, this Company reserves the right to withhold berthing permission for the vessel until the outstanding payment is fully settled.  
**C-٣-** Corporate "Sayyad" Cheque (Purple) amounting to ٦٠٠,٠٠٠,٠٠٠,٠٠٠ IRR, with a maturity date of September ٢٦, ٢٠٢٦ (٤ Mehr ١٤٠٥). The cheque must be issued South Kaveh Steel Company (SKSCO) and must be registered in the Sayyad System and a copy of the corresponding bank registration page shall be included in the submitted documents. It must be placed with this company to guarantee the payment. In the absence of such registration, the price offer shall not be subject to review.

All detention, fines and cost for nomination delays are on the buyer's account.
